## **Chief Davis:**

**Volunteers:** We have picked up a new 17-year-old volunteer and he has his EMT. Is having a meeting with Southern Ute HR next Wednesday to get an ad out on their newsletter to employees and the SU Drum.

**Drone program**: We are halfway through our internal course.

## **Fire Chiefs Report:**

We are currently at 473 responses. We are 25 calls ahead of last year. We spent almost a week on the Phoenix Recycling fire. One of our wildland crews was on the Arkansas Loop fire with BIA.

The June P&L was reviewed. We are just under 43% for total expenses, which is not bad for being halfway through the year.

**Training Tower:** The cost to repair the tower came to about \$75,000. The tower is structurally sound. Chief Harwig did put in for a FEMA grant to help with the cost of this for \$50,000 but there are four to six weeks left in the cycle before announcing grants.

**Capital projects:**We are working with Advantage Dodge to purchase a couple of administrative vehicles. They will give us \$23,000 for the trade in. They have sent quotes for two 2023 1500's which they split the trade in value between the two vehicles. The cost for one is \$48,000 and the other is \$46,000.

**Wildland Update:** We have two crews committed to severity. Dosh and Rees's crew are with BIA. Hunter and his crew are on severity with Columbine.

**EMTS** grant update: We were successful with the grant. We will be getting just under \$132,000 for a new ambulance.
