Drone: We have conducted 9 flights with training and using it out in the field.

## **Fire Chiefs Report:**

We are at 778 responses this year; we are up 19% on our volume from last year.

The August P&L is looking decent overall for this month. We are at 62.5 % for our overall expenses. We have received a couple of reimbursements. Capital is largely taken care of; we just have a couple of small things and the ambulance completion.

**Wildland Update:** We have a crew back in Idaho and the other crew started on Sunday with Columbine.

**2025 Budget:** The legislator in the special session agreed to and passed HB1001. The Initiatives 108 and 50 were pulled off the ballot. HB1001 will go into effect on next year's budget cycle. The total assessed valuation dropped 23%. Bud had questions about the La Plata County abstract and how they put it together regarding oil and gas. 83% of our revenue is oil and gas.
